Resolution 2004-07

A Resolution opposing the proposed amendment of the Douglas County Redevelopment Agency's Redevelopment Area #1, and authorizing actions of the Board to oppose the intended amendment, and including other matters related thereto.

Whereas, The Douglas County Redevelopment Agency has advertised its intent to request

the Douglas County Planning Commission and the Douglas County Board of Commissioners to approve an amendment to its Redevelopment Area #1, adding 36 identified parcels to the map of that Redevelopment area, many of which lie

within the current boundaries of the District, and

Whereas, The areas and parcels identified are either, 1) not in need of re-development

having never before been developed, or 2) do not meet any of the criteria allowed

as definitions of "blight", nor 3) are necessary to be included in the

Redevelopment Area #1 for the effective re-development of the Redevelopment

Area #1 as currently defined, or a combination of these, and

Whereas, The social and economic conditions of the proposed amendment area do not

substantiate the reasons provided for correcting blighted conditions within the

already and rapidly developing area, and

Whereas, District owned and operated water and sewer utility services are presently serving

and supporting the developments within Redevelopment Area #1 and it is economically feasible without this amendment for continued planned

development of the un-developed portions of the proposed amended Area, and

Whereas, Including the identified 36 parcels within the existing Redevelopment Area #1 is

neither necessary nor a proper use of public funding through the mechanism of

redevelopment, and

Whereas, The Board of Trustees of this District has an obligation to protect the interests of

property owners and residents within the boundaries

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Indian Hills General Improvement District, that this Board opposes the proposed amendment to the Redevelopment Area #1 and, further, that this Board authorizes and directs staff to present analyses, make reports, present testimony, or take any other action which could prevent the proposed expansion of Redevelopment Area #1.

BE IT FURTHER RESOLVED that, at the unanimous request of those District residents in attendance and/or speaking to oppose this amendment at this meeting, the Board herewith directs staff to affix to this Resolution the sign-in sheet for this meeting to show the opposition of those residents to the Redevelopment Agency's proposed amendment of the Redevelopment Area #1.
